HIGHLIGHTS

- Odin Energy finalised the sale of its 15.4% interest in Victoria Petroleum NL (VPE) on 27 October 2008 for \$ 9.8 million at a profit of \$1.475 million.
- On 20 November 2008 Odin Energy terminated the Farmin Agreement PEL 106 Spinel Block.

Corporate

Victoria Petroleum NL

The Company acquired a significant shareholding position in VPE, consistent with its overall aim of consolidating oil and gas assets in the Cooper Basin. At the time of sale it held 15.4% of VPE. The \$9.8 million inflow of funds in October will enable Odin to take advantage of opportunities in the markets to make further acquisitions. Messrs Bajada and Short have now resigned from the Board of VPE.

Operations

PEL 106 Spinel Block

The Farmin Agreement PEL 106 Spinel Block was terminated by notice to Kompliment Pty Ltd (a wholly owned subsidiary of Blue Energy Limited (BUL)). Odin Energy has commenced legal action for the return of \$4.5 million.
